Proposal To Replace Garfield School – Mayor Blackburn updated the council regarding a meeting with Assistant Superintendent Lee. Approximately 2.4 million dollars of state partnership funding for construction of ES17 is contingent upon relocating students from Garfield Elementary to the new school location. At a meeting with school administration on 8/3/22 the message was communicated that administration will not jeopardize partnership funding by not relocating Garfield students to ES-17. The city has the opportunity to obtain a grant to obtain funds to upgrade the school building but needs an easement and authorization from the school proceed with the grant application.
